## EXHIBITOR INFORMATION

**TRIAL SITE** will be open from 7:00 AM to 5:00 PM. Dogs may not be left overnight. There is little shade or protection from the weather at the site. Please bring shade cloth, tents, and chairs with you.

**FOOD:** There will not be food available on site. There are restaurants within walking/driving distance of the trial.

**DOGS ON GROUNDS:** *You are responsible for picking up after your dogs and disposing of waste in proper receptacles.* All dogs present must be held on leash or otherwise restricted except when being judged. Under no circumstances will dogs be allowed to disturb the resting stock or interfere outside the arena with another dog's performance in the arena. Unentered dogs are not allowed in the trial areas.

**PLEASE NOTE:** Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

## ENTRY INFORMATION

If sending entries overnight, make sure to sign the waiver that allows them to leave packages without a signature. Requiring a signature will only delay receipt of your entries.

A dog must be entered in the name of the person who actually owned it at the time entries for the herding test or trial closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any herding test or trial for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his or her name. State on entry form whether transfer application has been mailed to AKC (for complete rule refer to Chapter 14, section 3 of "Rules Applying to Registration and Dog Shows").

### **RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY.**

**ERRORS ON ENTRY FORMS:** Owners are responsible for errors in making out entry forms (whoever may make such errors) and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. Please type or print clearly and carefully the information on entry forms to eliminate errors.

**DECLINED ENTRIES:** Colonial Rotweiler Club may decline any entries and may remove any dog on account of disease, viciousness, or other cause and no one shall have any claim against the aforementioned mentioned club or any official thereof.

**ENTRY FEES SHALL NOT BE REFUNDED** in the event a dog is absent, not allowed to compete in the entered class, disqualified, excused, by a Veterinarian or Judge, or barred from competition by action of Show Committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or complete the Test/Trial, no refund of entries will be made.

**ALTERNATE LIST POLICIES:** When entry limits are reached, all additional entries received prior to closing will be added to an alternates list. The alternates list will be used to fill vacancies that occur in the drawn running order, with the first available alternate entry replacing the first vacancy in the class entered. In Test Classes, alternates shall be given priority over dogs eligible to be moved-up.

**BITCHES IN SEASON** will be permitted to run but will be placed at the end of the running order in Tests and in catalog order for Trial classes. Please notify the Trial Secy before the beginning of the class if your bitch is in season.

**No dog may be entered in two classes on the same course with the same kind of stock under the same judge at any Test or Trial.**

## DIRECTIONS

**From I-78/I-80/Allentown:** **DUE TO RT 82 CLOSED SOUTH OF BIRDSBORO, THESE ARE ALTERNATE DIRECTIONS.** Follow Rt 100 South to Rt 23. Turn right onto Rt 23 (Ridge Rd). Turn right onto Rt 82 (Twin Valley Rd/Elverson Rd). You will go up a hill past the Twin Valley School District HQ and around to a 4 way stop. From there, go 4.8 miles through Geigertown (*DO NOT follow Route 82 detour sign! Keep going - you will be at Scarlet's Mill before you get to the actual detour*) to the stop sign. Bear LEFT at the stop sign. Trial site is the first drive on the left (two stone pillars at entrance of drive). Please use second driveway for parking.

**From the PA Turnpike exit 298:** Take Route 10 North/Beckersville 0.6 miles, then turn RIGHT onto Joanna Rd. Go 0.9 miles to stop sign (at Joanna Store) and turn RIGHT. Go 0.4 miles to the stop sign and turn LEFT onto Route 82 North (Hay Creek Road/Twin Valley Rd). Go 4.8 miles through Geigertown (*DO NOT follow Route 82 detour sign! Keep going - you will be at Scarlet's Mill before you get to the actual detour*) to the stop sign. Bear LEFT at the stop sign.
