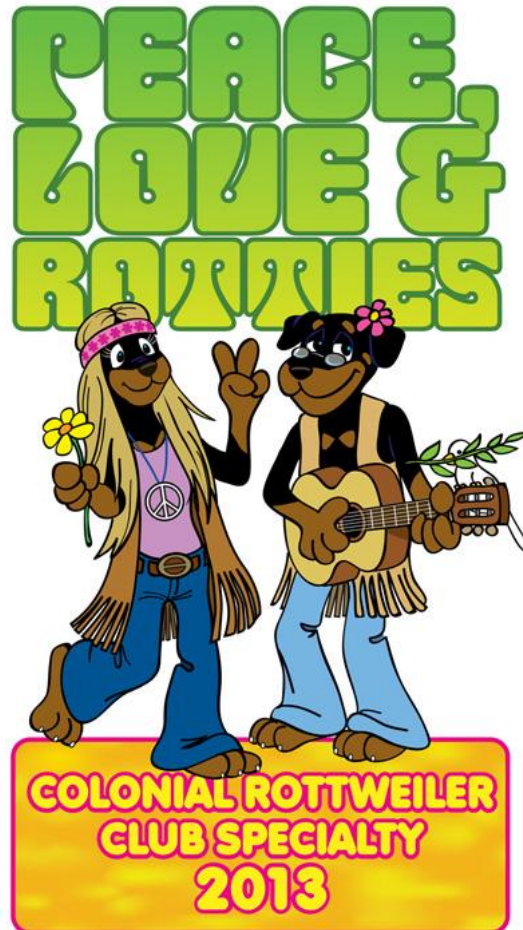

Test Hours

The drawing for TD tracks will at 8:00 am at the Test Headquarters and TDX tracks will be drawn at 9:45 am. Judging will begin as soon after the drawing as the tracks have sufficiently aged and the judges are ready.

NOTICE TO EXHIBITORS

CERTIFICATION: An original statement, dated within one year and signed by a person who has been approved by the American Kennel Club to judge tracking tests (or a Provisional Tracking Judge), certifying that the dog is considered ready for such a test must be included with the entry form for a dog who has not passed a Tracking Dog test.

FAX, TELEPHONE AND UNSIGNED ENTRIES CANNOT BE ACCEPTED

Entries not on official AKC entry forms and photocopies of entry forms without the Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE

ERRORS ON ENTRY BLANKS: Owners are responsible for errors on entry forms, whoever may make such errors. No entry fee will be refunded in event of errors or cancellation of entry after the published closing date.

NO ENTRY SHALL BE MADE and no entry shall be accepted which specifies any condition as to its acceptance. Entries cannot be accepted, canceled, altered, or substituted after the entries have closed.

ENTRIES WILL NOT BE ACCEPTED WITHOUT FEES. The fee for TD is \$85. The fee for TDX is \$125.

ENTRIES CLOSE: 5:00 PM, Thursday March 14, 2013, after which time no entries may be accepted, canceled or substituted except as provided for in Chapter 11, Sec. 6 of the Dog Show Rules. Entries will be drawn by lottery per Chapter 1, Sec. 17 of the Tracking Regulations as relating to specialty clubs. Entries will be drawn at 15911 Jerald Rd. Laurel, Maryland 20707, March 15, 2013 at 7 PM

NUMBER OF TRACKS: 4 TD, 3 TDX tracks. Rottweilers will be given preference. If the limit for entries is not reached in one test and the limit for entries is exceeded in the other test, the number of tracks may be exchanged as allowed in the tracking regulations. Any remaining tracks will be open to all other AKC recognized breeds.

REFUNDS: Entry fees will be refunded for entrants who withdraw and give the Test Secretary sufficient time to contact an alternate to fill that dog's vacancy; the entry fee is NOT refunded if there is no alternate to take the available spot. Fees for alternates who do not participate will be refunded within seven (7) days following the Test.

BITCHES IN SEASON may participate in this test, per Chapter 2, Section 8 of the Tracking Regulations.

FOOD: There will be complimentary refreshments available the morning of the test. Lunch will be provided after the test. No other food will be available on-site.

WEATHER: The club reserves the right to cancel the event in extreme weather conditions.

NOTE: The test site is a public park so handlers should be ready for distractions. This area has been known to have a lot of ticks and poison ivy so please be prepared. Exhibitors are requested to not practice at the test site within three days of the test without first contacting the Test Chairperson to find out which areas may be used.

From the South:

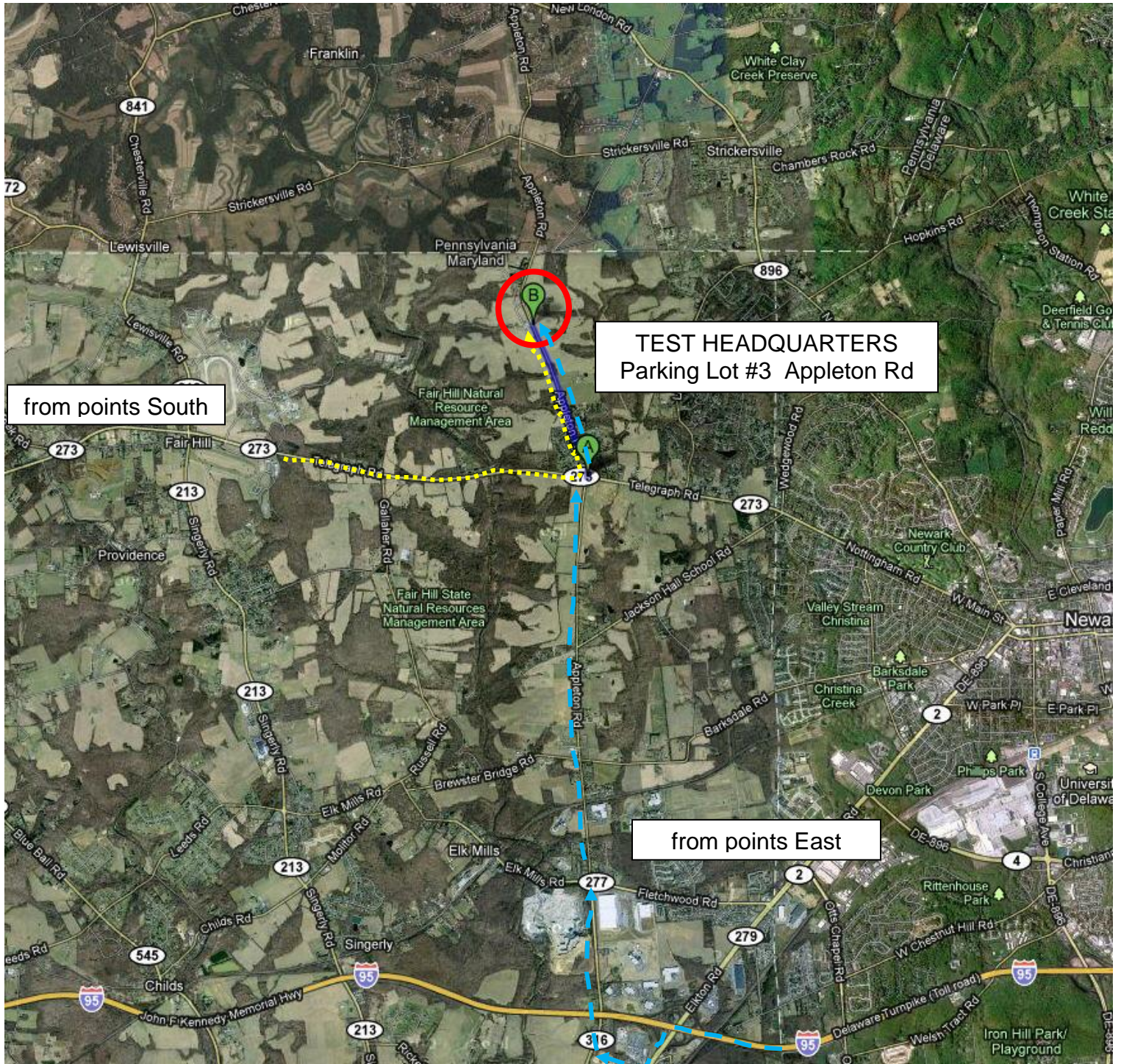

From the North and East:

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
